Reference: lead, mercury, cadmium, hexavalent chromium, polybrominated biphenyls, polybrominated diphenyl ethers, including pentabromodiphenyl ether, octabromodiphenyl ether, decabromodiphenyl ether, Perfluorooctanoic Acid, and Perfluorooctane Sulfanates are not intentionally added to the raw material used for; Brass, Tellurium Copper, any raw material for contact clips, plastic moulding compounds and epoxy laminates for insulators, or plantings' of; copper, nickel, gold, and pure tin except where described and allowed under item 6 of the annex; Applications where lead mercury, cadmium, and hexavalent chromium, which are exempted from the requirements of Article 4 (1) of reference 1.

To the best of our knowledge, none of our raw material suppliers use these restricted substances to manufacture their products. CurrentCare Ltd does not intentionally add these restricted substances to its products during processing. This statement is based on information provided by the suppliers of products which contain such raw material products, and covers all products you purchase from CurrentCare Ltd. Unless advised separately.

Please note that CurrentCare Ltd and its suppliers do not analyze its products for substances not purposely added. Trace amounts of any chemical and substance might be found as impurities in any product.
